Committee members have the right to sift a horse at any time prior to the horse being sold. There will be no "*behind the barn*" sale of horses that are sifted.

All consigners are required to attend a meeting at 9:00 AM, in sale area, the morning of the sale.

All horses will be led into the sales ring by a committee member.

Registration papers, with signed transfer, and proof of ownership on unregistered horses must be produced prior to the sale.
